ORDINANCE NO. 6748-07-2022

AN ORDINANCE AMENDING CHAPTER 46 ARTICLE V
OF THE EDWARDSVILLE CITY CODE,
LIFE SAFETY CODE,
FOR THE CITY OF EDWARDSVILLE

WHEREAS, the City of Edwardsville has previously adopted National Fire Protection Association (NFPA) 101 *Life Safety Code, 5th edition, 1997*, and all subsequent amendments thereto and future editions of the same as published by the National Fire Protection Association, therefor; and

WHEREAS, the City of Edwardsville finds that it is appropriate to review and update its building codes from time to time and believes it in the best interest of the community to adopt the National Fire Protection Association (NFPA) 101 *Life Safety Code 2015* as specified in ordinance amending Chapter 46, Article V.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EDWARDSVILLE, MADISON COUNTY, ILLINOIS that:

Section 1. The following section of Chapter 46 Article V is hereby amended in its entirety to read as follows:

Sec. 46-130 – Adoption of code and future editions as may be amended/adopted by State of Illinois.

A certain document, being marked and designated as National Fire Protection Association (NFPA) 101 Life Safety Code, 2015 edition and all subsequent amendments thereto and future editions of same as published by the National Fire Protection Association, be and is hereby adopted as the life safety code of the city, setting forth specific requirements that have a direct influence on safety to life in both new and existing structures. The paramount concern is life safety and not exclusively protection of property; and each and all of the regulations,

provisions, penalties, conditions and terms of said Life Safety Code on file in the office of the City of Edwardsville are hereby referred to, adopted, and made a part hereof, as if fully set out in this ordinance, with the additions, insertions, deletions and changes, if any, prescribed in Section 2 of this ordinance.

Section 3. That Ordinance No. 5024-8-97 and all other ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. That if any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

Section 5. That nothing in this ordinance or in the Code hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

Section 6. That the City Clerk is hereby ordered and directed to cause this ordinance to be filed and published in accordance with the laws of the State of Illinois.

Section 7. That this ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect from and after the date of its final passage and adoption.
